

#### 4. FIRST AID MEASURES

#### **Environmental Precautions:**

In the event of a major spill, prevent spillage from entering drains or water courses.

#### Methods and Materials for Containment and Cleaning Up:

Move containers from spill area. Avoid dust generation. Using a vacuum with HEPA filter will reduce dust dispersal. Place spilled material in a closed, labeled waste container. Do not dry sweep. Cured product is considered non-hazardous.

## 7. HANDLING AND STORAGE

#### **Precautions for Safe Handling:**

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Contaminated work clothing must not be allowed out of the workplace. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

## **Conditions for Safe Storage:**

Store in a cool, dry and well ventilated area. Protect from direct sunlight. Do not store above 30 °C. Keep in original container tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers.
